**ORDER FOR SUBSTANCE
USE EVALUATION**

11 Ms. Jackie Rothschild, PharmD, (“Respondent”) personally appeared
12 before the Arizona State Board of Pharmacy (“Board”) on October 4, 2017, seeking
13 termination of probation and the terms associated therewith pursuant to the Consent
14 Agreement and Order dated May 3, 2010.

15 In determining the matter, the Board reviewed the record, including the current
16 Consent Agreement and Order and considered statements from Respondent. At the
17 conclusion of its consideration of the matter, the Board determined that a substance use
18 evaluation was in order. **THEREFORE,**

- 19 1. **IT IS ORDERED THAT** Respondent shall obtain a substance use
20 evaluation within sixty (60) days of the effective date of this Order. The
21 effective date of this Order is the date it is signed by the Board’s Executive
22 Director.
- 23 2. **IT IS FURTHER ORDERED THAT** Respondent shall select a Board pre-
24 approved evaluator within fifteen (15) days of the effective date of this order
25 and notify the Board’s Executive Director of the name of the selected

1 evaluator. **The evaluator must be pre-approved by the Board's Executive**
2 **Director.**

- 3 3. **IT IS FURTHER ORDERED THAT** Respondent shall ensure that the
4 evaluator submits his/her report to the Board's Executive Order within thirty
5 (30) days after the evaluation is complete. Respondent shall sign all
6 necessary forms and releases to authorize the evaluator to send the evaluation
7 directly to the Board.
- 8 4. **IT IS FURTHER ORDERED THAT** Respondent shall pay all costs and
9 expenses related to the evaluation that is the subject of this Order.
- 10 5. **IT IS FURTHER ORDERED THAT** Respondent understands that the
11 decision to terminate Respondent's probation is within the sole discretion of
12 the Board, taking into consideration the results of this most recent evaluation.
- 13 6. **IT IS FURTHER ORDERED THAT** Respondent understands that this
14 Order is a public record that may be publicly disseminated as a formal action
15 of the Board.
- 16 7. **IT IS FURTHER ORDERED THAT** that any violation of this Order
17 constitutes unprofessional conduct under A.R.S. § 32-1901.01(B)(20),
18 violating a formal order, terms of probation, a consent agreement or a
19 stipulation issued or entered by the board or its executive director pursuant to
20 Chapter 18.
- 21 8. **IT IS FURTHER ORDRED THAT** all other terms and conditions of the
22 DATE Consent Agreement and Order remain in full force and effect.
