A patient received an antibiotic that was dosed too high for the patient's age and body weight.

Recommended Action: Permit Holder - Offer a consent agreement for \$200 civil penalty with standard terms; if permit holder does not sign the consent or pay the penalty, move to formal hearing. Tech - Offer a consent agreement for \$120 civil penalty with standard terms; if licensee does not sign the consent or pay the penalty, move to formal hearing. A complaint was received alleging numerous non-compliant activities taking place within the pharmacy. A compliance officer contacted the complainant to obtain additional detail. The complainant stated the pharmacy was disposing of hazardous waste into a public dumpster, compounding activity was performed within a hood that failed certification, lack of cleaning supplies to deactivate hazardous chemicals, no monitoring of controlled substances was taking place, compounding staff were not in compliance with USP 800 garbing requirements, management was allowing technicians to perform activities reserved for a pharmacist, temperatures within the pharmacy compounding room exceeding 80 degrees F, compounding of a commercially available product and compounding staff were not using reference materials to support potency adjustments. The permit holder provided a response to each of the allegations either denying the allegation or an explanation to the alleged non-compliant activity. Violation notices issued during a recent pharmacy inspection conducted were unrelated to the complainant's allegations. A visit conducted to investigate this complaint

Allegations were investigated but not substantiated by available evidence. A possible violation of pharmacy law was not identified.

22-0274 A

A complainant alleged the pharmacy dispenses counterfeit Dextroamphetamine 10mg tablets, that are weaker in strength, diverts medication and violates PHI laws. Upon investigation, the medication did not appear to be tampered with and the pharmacy provided invoices from the wholesaler, a currently permitted entity in AZ (no discipline on file). The district manager stated that there is no proof of the staff tampering with the tablet or violating any HIPAA laws. The pharmacist listed in the complaint stated that each controlled substance is inspected and sealed upon arrival at the pharmacy.

did not find any additional violations.

Allegations were investigated but not substantiated by available evidence. A possible violation of pharmacy law was not identified.

22-0279

Board staff received a complaint stating that the complainant was not receiving her receipt for her prescription and needed to call and wait seven (7) days for it to process and then wait another ten (10) days for the receipt. Board staff received a second complaint stating the same prescription was received outside of the allowable temperature parameters of the manufacturer. The Pharmacist-in-Charge stated all patients are provided a basic invoice as well as a patient literature pack. The information the complainant is requesting can be obtained by two options. The pharmacist stated a customer service representative reached out to the complainant to go over these options however the complainant disconnected the call prior to receiving the information. The pharmacist also explained the process involved in delivering temperature sensitive drugs. The decision was made to replace the medication because the pharmacist determined that the medication was not delivered in the timeframe expected. The replacement was delivered and packaged according to system standards. The complainant has not contacted to pharmacy since the delivery of this invoice and package.

Allegations were investigated but not substantiated by available evidence. A possible violation of pharmacy law was not identified.

22-0291

A patient filed a complaint alleging that a pharmacy continued to autorefill his prescriptions without his approval. The Pharmacist-in-Charge ("PIC") responded and verified that the auto-refill feature was deactivated from the patient's profile. The PIC also stated that he reviewed the patient's profile to ensure that all medications were not enrolled in autorefills.

Customer service issue related to courtesy, dignity, or respect.

22-0296 A complainant had a prescription for a 90-day supply sent to a pharmacy. Customer service issue related to courtesy, dignity, or respect. She states she picked up the prescription and realized she was only given #30. She called the pharmacy and spoke to a technician who informed her that the insurance would not cover a 90-day supply. The complaint states she requested the pharmacy to call her doctor to request a prior authorization, however the technician became rude and placed her on hold sending her to voicemail. She states she called back and was again sent to voicemail after requesting to speak to the pharmacist. The pharmacy technician's version of events does not differ greatly from the complainant other than she does not feel she was rude. She states that

the phone system automatically sends individuals to voicemail after they

In February 2022, the Board was notified that three (3) employees of a 22-0065 pharmacy (technicians) had been terminated because they had been billing prescriptions for themselves at the 340B cost, rather than billing their respective insurance plans. Given the nature of the case, it has been turned over to another agency.

have been on hold for a certain period of time.

Complaint referred to another agency with jurisdiction over the allegations filed with the Board.

22-0313 A prescriber alleged that a pharmacy was ignoring her requests to cancel any remaining refills on a previously-filled controlled substance prescription. A prescriber electronically sent a controlled substance prescription (P1) to a pharmacy with instructions in the notes area to cancel any refills on previously filled prescriptions. A previous prescription (P2) was then refilled two times after the transmission of this prescription. The prescriber then electronically canceled P1 23 days later. P1 was never filled. The patient is no longer under the care of this prescriber. The Pharmacist-in-Charge stated that P1 was received and stored by the computer due to a refill-too-soon situation with a previous fill. The note was not reviewed due to the refill-too-soon situation and the prescription was never filled as it was cancelled by the prescriber.

Pharmacy team did not have access to the information to make an informative decision; Prescriber notes were not readily accessible to staff on the profiled prescription; Use of professional judgment to address a prescription order.

22-0328 A patient filed a complaint because a pharmacist refused to fill her controlled substance prescription. The pharmacist stated that he did not feel comfortable filling the prescription because the patient's pharmacy profile from a different pharmacy showed that the patient should have a current Percocet prescription. The patient's PMP profile did not reflect this because the patient had filled the Percocet at a pharmacy in California and the Arizona PMP is not connected to the California PMP.

22-0343

Customer service issue related to courtesy, dignity, or respect; Use of professional judgment to address a prescription order.

A complaint was opened by board staff to address three (3) inspection equipment failures due to the pharmacy security gate(s) not securing when closed. During one of the inspections the gate initially passed only to have the gate fail when it was inadvertently opened before unlocking the securing pins which were subsequently sheared off rendering the gate non-compliant for AAC R4-23-609(F). The permit holder notified the compliance officer on 6/22/2022 that the gate was repaired again and ready once again for an inspection. On 6/24/2022 the gate passed an equipment check inspection. On 7/9/2022 the permit holder confirmed signage has been posted at each of the thirteen (13) pharmacies that utilize the electric motorized gates to prevent another incident where an operator raises the gate before unlocking the securing pins.

Issue resolved upon further re-inspection: There was no public safety

22-0348 A complainant alleged he was asked not to return to the pharmacy after the pharmacist told him to stop yelling. The complainant indicated he needed his medication as he has Covid. Per the Pharmacist-in-Charge, the complainant was in the drive through and was upset as his prescriptions had not been received. The complainant then requested to purchase pseudoephedrine in the drive through and was denied. The complainant's anger escalated, and he started to use profanity. The technician informed him they could not sell pseudoephedrine in the drive through and he

wasn't welcome to return.

Customer service issue related to courtesy, dignity, or respect; Duration of time to fill a prescription order; Medication not in stock, back ordered, or otherwise not immediately available.

22-0355

Two (2) patients alleged that they were refused a COVID vaccine booster after they arrived for a scheduled appointment. The patients scheduled an appointment for COVID vaccine boosters that were ordered via prescription from a prescriber. When they arrived for their appointment, they were told that they were up to date and did not need an additional booster. They reminded the staff that they were told that they could get an additional booster if ordered by a doctor. A written statement from the pharmacist explained that the patients were originally told that they would have to get an additional booster administered by a prescriber as they had already received the maximum number of doses allowed by a pharmacist.

Customer service issue related to courtesy, dignity, or respect; Use of professional judgment to address a prescription order.

22-0358

A patient claims that the pharmacy refused to "dispense a legal and legitimate prescription" for a pain medication. The patient also states that professional judgment to address a prescription order. the staff at "this pharmacy is making medical decisions that they are NOT qualified to make and that these decisions are adversely affecting patient care, the physicians care plan and the continuity of medical care." The Pharmacist's response states that the prescription was sent electronically and could not be filled as it was too early to fill, with no change in directions or quantity. The pharmacist on duty attempted to get verbal approval from the doctor's office on three different days with no response. The prescription was subsequently filled at a different pharmacy with a change of directions and quantity.

Customer service issue related to courtesy, dignity, or respect; Use of

22-0366

Medication was not ready when the complainant went to the pharmacy. The complainant indicates she returned to the pharmacy after thirty (30) minutes and the medication still was not ready. Per the District Manager, the medication was filled and picked up by the complainant that same

Customer service issue related to courtesy, dignity, or respect; Duration of time to fill a prescription order.

22-0370

A complainant alleges two (2) scheduled CII medications were sold to an unauthorized person/caregiver. A hospice delivery driver was expecting to pick up two (2) medications but was told upon arrival at the drive thru that the scripts mentioned had already been previously sold. A compliance officer reviewed surveillance video on the date and time of the incident to determine if an authorized person or caregiver picked them up. Video clearly shows the two (2) prescriptions in question being scanned and sold to a person who successfully completed a pin-pad verification from memory using the patient's last four digits of telephone number. The person provided verbally the name and address based on policy and procedures and also entered their member rewards number that matched the full telephone number of the patient's profile.

Allegations were investigated but not substantiated by available evidence. The investigation did not identify a possible violation of pharmacy law.

22-0375 A complainant alleged a pharmacist refused to fill two (2) prescriptions and violated his HIPAA rights when she asked personal medical history information. The pharmacy received prescriptions for two (2) medications for the complainant. The pharmacist indicated she refused to fill the prescriptions due to multiple unresolved red flags. The red flags included early refill of a different CII opioid by same prescriber, the complainant insisting on paying cash when prior authorization required, and inconsistent information about diagnosis and treatment from the complainant and prescriber.

Customer service issue related to courtesy, dignity, or respect; Use of professional judgment to address a prescription order.

22-0384 A

A complainant alleged that a pharmacist told her that Arizona does not allow pharmacies to fill prescriptions for pets. When she called the Board office, the female who answered the phone told her that Arizona allows all pharmacies to fill these prescriptions. A competitor chain also said that they can fill these prescriptions. The compliance officer spoke with the pharmacist who was working that day. They were unable to fill the prescription as it was not available for them to order. The pharmacist called the veterinarian to ask about an alternative and the veterinarian denied the request because they had dispensed the medication to the client at the office on the day of the visit.

Customer service issue related to courtesy, dignity, or respect; Use of professional judgment to address a prescription order; Medication not in stock, back ordered, or otherwise not immediately available.

22-0385

A patient filed a complaint stating that the pharmacist treated her with "such disrespect and harassment." Furthermore, she stated that when she asked for help, the pharmacist was "belittling," "rude," and "demeaning." According to the patient, the pharmacist made a "derogatory remark on my heritage." Pharmacist response stated that the patient was displeased about a late delivery of her medication by 1-2 days. The discussion went back and forth, eventually ending up in arguments and yelling.

Customer service issue related to courtesy, dignity, or respect.

22-0386

A complainant alleged that the pharmacist refused to give him an approved booster COVID vaccine. The patient received his initial series plus a booster as indicated on his vaccine card. The pharmacist entered the information into the CDC eligibility website and it indicated the patient was up to date on his COVID vaccine. The pharmacist was not comfortable administering outside of CDC and company guidelines.

Use of professional judgment to address a prescription order.

22-0387

out loud the medical conditions of customers and cross referencing them with their medication. The complainant also alleged the pharmacist questioned her husband's prescription stating "I don't know what your physician is prescribing. That's not correct." Lastly, the complainant alleges the pharmacist has offered medical advice by stating the physician should prescribe a specific medication to treat a certain medical condition. The pharmacist stated he remembers obtaining the patient name and date of birth to confirm her prescription and upon confirmation the pharmacist discussed the time frame of her next refill. The pharmacist denied assuming the role of the medical provider, however he does provide relevant information about a patient's medication. The pharmacist denies speaking loudly stating he does not pry about a patient's medical condition but does ensure a patient is picking up the correct prescription. The pharmacist denies questioning the prescription prescribed to the complainant's husband. The pharmacist shared the pharmacy security video for the sale of the involved prescription with the compliance officer. While the video contained no audit it did appear to show a normal interaction between the pharmacist and complainant with no indication of shouting observed.

A complaint was received from a patient alleging a pharmacist was stating out loud the medical conditions of customers and cross referencing them professional judgment to address a prescription order.

A complaint was received from a patient of the pharmacy stating the pharmacist refused to dispense a medication that the doctor had been prescribing for the past two (2) months. The patient stated the pharmacist did not allow the patient any time to figure out a resolution and no other pharmacies had the medication in stock which would result in additional delays waiting for the drug to be obtained. The permit holder response stated the pharmacist chose not to fill the medication received on 6/27/2022 pending a clinical discussion with the prescriber. Beginning on 6/27/2022 the pharmacist made several attempts to contact the prescriber. After receiving no response, the pharmacist provided the patient with a partial supply on 7/01/2022. The pharmacy contacted the prescriber again on 7/05/2022 and was told by staff that the prescriber would be out of the office until 7/11/2022. The pharmacist once again provided the patient with another partial fill to last the patient until 7/12/2022. The permit holder stated that the pharmacy never received a return call from the prescriber and the patient subsequently filed the complaint.

Customer service issue related to courtesy, dignity, or respect; Use of professional judgment to address a prescription order; Medication not in stock, back ordered, or otherwise not immediately available.

22-0391

A patient alleged negligence and cruelty by a pharmacy and onsite clinic staff. The patient arrived at the pharmacy and wanted to be seen by the onsite clinic for an ear problem. Unable to register for an appointment due to the computer being down, she was told by the pharmacist to go home and book an appointment online. The store manager apologized that he could do nothing. The clinic nurse said she could not see her as she was too busy. A written statement from the pharmacist indicated that he told the patient that she likely would not be seen without an appointment unless there was a cancellation. The store manager tried to assist the patient to book an appointment and the earliest appointment time available was 72 hours away.

Customer service issue related to courtesy, dignity, or respect.

22-0394

A prescriber states that the pharmacist and pharmacy manager were refusing to fill a non-controlled prescription, without the prescriber providing a DEA number. Pharmacist and pharmacy manager state that they could not find the prescriber in their system, so they asked for a DEA number or NPI number. The prescriber being a veterinarian, was only able to offer a Veterinary license number. The pharmacy staff was unsuccessful using the veterinary license number. The pharmacy staff now has a way to work around this situation and has communicated it to the entire team, including the district leader.

Customer service issue related to courtesy, dignity, or respect.

22-0397

A patient alleged that the pharmacy refused to dispense her prescription and sold prescriptions to her for her adult children without request. The patient submitted four (4) complaints surrounding this issue. In one addendum to the complaint, the patient alleged that the pharmacy refused to fill one of her son's prescriptions necessitating that the tablets be split and causing the medication to run out early. The patient is locked into a single provider for prescriptions by AHCCCS. The prescription was written by a non-approved provider. The patient was informed of the situation at the drive-thru window and refused to leave. The police were called to remove her from the drive-thru. She changed her provider with AHCCCS and returned at a later date to pick the prescription up. The prescription was adjudicated and she again refused to leave the drive-thru while the prescription was filled, resulting in the police being called again. After entering the store, using inappropriate language, and throwing a prescription at the pharmacist she was trespassed from the store. The prescriptions sold to the patient for her sons were verified by name and date and birth at the drive-thru window and the complainant is listed as their caregiver. In one of the additional submissions she identified herself as their parent, legal guardian, representative, and advocate of record. The son's prescription that could not be filled had been discussed with her by the pharmacist on previous occasions. The son can only receive white tablets free of dye and the pharmacy was unable to obtain such a tablet in one of the strengths. The patient had been notified in June that she was trespassed from this store and would need to transfer her prescriptions elsewhere. When she called in July to fill the prescription she was again told this.

Payment or pricing related matters; Customer service issue related to courtesy, dignity, or respect; Use of professional judgment to address a prescription order; Medication not in stock, back ordered, or otherwise not immediately available.

A patient filed a complaint because her prescription was not ready, after dropping it off the day before, and the pharmacist screamed at her in front of everyone in the store. The pharmacy had not filled the prescription because it wasn't going through the insurance. The pharmacy staff made several attempts to bill the prescription through the patient's insurance, but it was rejected because the patient's primary insurance was not contracted with the pharmacy. The patient requested to pay cash for her medication instead. The patient alleged that the pharmacist became irate and was yelling at her in front of everyone. The pharmacist stated that he was frustrated because his staff was being mistreated by this patient. Ultimately, the patient received her medication.

Payment or pricing related matters; Customer service issue related to courtesy, dignity, or respect; Duration of time to fill a prescription

22-0399

A patient alleged that a pharmacist refused to fill her prescription for Paxlovid because she was not on a ventilator and "not sick enough". The compliance officer spoke with the patient for further clarification. The patient stated that her husband was the individual who spoke with the pharmacist and related the information in the complaint. The patient stated that she spoke to a female who answered the phone at the Board office and was given scenarios in which a pharmacist could refuse to fill a prescription. Since the scenarios provided by the office staff did not apply to the patient, she filed a complaint. The compliance officer spoke to the pharmacist who stated that she informed the patient's husband that she could not fill the prescription until the prescriber responded to her request for the patient's GFR due to the potential for a severe adverse reaction. This is documented in the prescription notes. At the patient's request, the prescription was transferred to another pharmacy. The prescriber called to respond to the request after the prescription was already transferred. It appears the patient's husband misunderstood or incorrectly relayed the information that was given by the pharmacist.

Customer service issue related to courtesy, dignity, or respect; Use of professional judgment to address a prescription order.

2022-31

A practitioner indicated a mortuary called her to sign a death certificate for an individual that was never her patient. Per the practitioner, the wife showed the mortuary six (6) prescription bottles listing the practitioner as law. the prescriber. A second email was received where the practitioner indicated it was not her but another physician with a similar name. The information below had already been collected on 8/15/22. The practitioner was unable to provide any pharmacy information. The CSPMP was checked using the patient name and date of birth provided in the complaint. The original search using a one-year search term did not provide any data. The search was expanded to a three-year search term and resulted in one prescription on the report, but the prescriber was not the practitioner that filed the complaint. The pharmacy listed on the CSPMP report was contacted to review non-controlled prescriptions. Per the pharmacist, no prescriptions from this practitioner were found in the database for the last two years. One prescription was found from last October from a practitioner with a similar sounding last name. Unable to search for additional non-controlled prescriptions without pharmacy information.

Allegations were investigated but not substantiated by available evidence. The investigation did not identify a violation of pharmacy .

A complaint was received alleging a pharmacy technician was dispensing medications from a doctor's office without pharmacist supervision. A dermatology office employed a technician in what their website referred to as their pharmacy. This is a doctor's office and a permitted pharmacy does not exist at this location. A separate complaint is open to address the technician. The compliance officer met with the physician who was not aware that the website advertised a pharmacy. He immediately took action to change the website. The website no longer refers to a pharmacy, but rather to a physician dispensary. He was unaware of the issue of employing someone as a pharmacy technician. He changed the technician job title and had the technician remover her license from the wall. A discussion with the technician revealed that she was responsible for data entry, DUR, and dispensing to the patient. Since this appears to be a violation of the Arizona Medical Board's physician dispensing rules, the complaint review committee at the September 27, 2022 meeting

requested the complaint be forwarded to the Medical Board.

Referred to Board of Medical Examiners

22-0542

to a drug interaction. The patient presented a prescription for a narcotic to the pharmacy on a Friday. An interaction was noted with a prescription that had been filled at another pharmacy. The pharmacist made the decision not to fill the prescription until discussing with the prescriber. The patient came to the pharmacy over the weekend and dumped her tablets on the front counter and demanded the pharmacist fill her pain medication. The pharmacist on duty refused to fill the prescription for the same reason as the prior pharmacist. The patient refused to take the tablets back off the counter and they were left there for some time while patients were rung up at the other window. The pharmacist was able to speak with the prescriber who said the pain medication could be filled only if the patient was no longer taking the other medication. The pharmacist discussed this with the patient and filled the pain medication upon the patient stating she would no longer take the other prescription.

A patient alleged that a pharmacist refused to fill her pain medication due Customer service issue related to courtesy, dignity, or respect; Use of professional judgment to address a prescription order.

22-0400

An employee of a veterinarian's office alleged that the pharmacist refused Customer service issue related to courtesy, dignity, or respect. to refill a medication for a non-controlled medication without a DEA number. The pharmacy received a new prescription on the pharmacy voice mail for a non-controlled medication prescribed by an out of town veterinarian. The pharmacist was unable to locate the prescriber in the computer system and in order to perform a wider search needed a DEA number or NPI. The office refused to provide the DEA number or to send the prescription to another pharmacy. The DEA number was requested in order to search for the prescriber in a central database, not to fill the prescription. The compliance officer asked the pharmacist if he attempted to enter the new prescriber into the computer. The pharmacist believed that the computer would not allow entry of a new prescriber into the system without a DEA number or an NPI. The compliance officer educated the pharmacist on how it can be accomplished in the computer with a state license, which he will now utilize in the future when necessary.

A complainant alleged a pharmacist offered a subjective opinion on her medication which he was not qualified to make and the opinions were intended to be heard by others as a technician and patient were within six (6) feet. The pharmacist indicated he observed the complainant might be pregnant when she picked up the medication and he counseled her on the new medication. He indicated when the complainant returned to the pharmacy with her husband they said his responsibility was to make sure the medication is filled correctly and not tell people about their medications. Pharmacy records were reviewed. The pharmacy had never filled the medication for the complainant prior to July 2022. Counseling was documented as accepted. Video of the interactions were viewed. On the first interaction, the complainant was at the pharmacy counter and the next patient visible was behind the pharmacy privacy signapproximately eight (8) regular steps to the pharmacy counter. The pharmacist is observed speaking with the complainant. The next patient did not move towards the pharmacy counter until the complainant left. On the second interaction, a patient was at the pharmacy counter interacting with a technician and the complainant and her husband came directly to the counter without stopping behind the privacy sign. The pharmacist is observed coming to the counter, then he and the complainant and her husband all move away from the counter to the drop-off window. The patient and technician were still at the main

22-0410

counter area.

A pharmacist had been administering vaccinations since his last license renewal in 2020, but his immunization certification status showed "inactive". On 7/26/22, the pharmacist contacted the Board office to ask why his immunization certification status showed inactive. Upon examining his renewal application from 2020 and after receiving further clarification, Board staff concluded that although he affirmed he was a certified immunizer, he mistakenly checked "no" on the question asking if he had completed the CE requirement for immunizations. This caused his status in the database to be "inactive"; however, the license he received and printed upon renewal stated "certified immunizer". He provided the necessary documentation proving he had completed the required CE prior to renewing his license. Board staff then changed his status to active on 7/27/2022.

A licensee answered a question incorrectly on his renewal application and subsequently provided appropriate supporting documentation. The investigation did not identify a possible violation of pharmacy law

22-0420

The patient alleges the pharmacy staff incorrectly cancelled an active prescription order without the providers explicit direction. Compliance officer review of pharmacy documents confirmed a note entered on7/26/2022 with prescriber authorization to close the script. Documentation notes contained the name of the prescriber's agent that requested the deactivation. During the investigation visit, the compliance officer requested the Pharmacist in Charge (PIC) to call the listed office to validate the previous notes. The phone conversation corroborated both the name of the medical assistant and the correct provider matching the original hard copy.

Customer service issue related to courtesy, dignity, or respect; Use of professional judgment to address a prescription order.

22-0422 The Board office received a complaint on 7/28/2022 alleging that the staffing issues at a rural pharmacy were resulting in patients not being able to pick up their medications. The complainant also stated that other pharmacies had tried to contact the respondent for prescription transfers, but the staff would not answer the phone. The previous Pharmacist-in-Charge left the company on 7/1/22, and the permit had been utilizing temp agencies to staff the pharmacy. Then on 7/29/22, the Board received notice that the pharmacy would be temporarily closed from 8/1/22 until 8/19/22, due to lack of pharmacist coverage. The clinic notified their doctors and patients that another pharmacy would temporarily fill their prescriptions. The clinic also offered to drive patients to this location for prescription pick-up.

Customer service issue related to courtesy, dignity, or respect; Duration of time to fill a prescription order; Medication not in stock, back ordered, or otherwise not immediately available.

22-0425 A complainant states the pharmacy failed to sell him pen needles with his injection pen. He states that that pharmacy did fill them a few days later. He also states his blood pressure medications were filled a week late and a mistake was made on his blood thinner medication. He states this error left him in the hospital with blood clots. Per the pharmacy profile for this patient-there were no blood pressure medications or blood thinner medications on file. The Pharmacy Practice Coordinator went back to January 2022 and found no fills for any of these types of drugs. She sent

several screen prints of fills for the injection pen and it's needles.

Customer service issue related to courtesy, dignity, or respect; Duration of time to fill a prescription order; Medication not in stock, back ordered, or otherwise not immediately available.

22-0426 A complainant alleged her prescription sent over on 7/28/22 was still not available on 8/1/22 as the pharmacy did not have the medication in stock and could provide no information on when it would be available. The Pharmacist-in-Charge ("PIC") indicated the prescription had been placed in pending inventory as it was out of stock and on back order. The complainant called on the weekend and was unhappy the medication was not in stock. Per the PIC, the doctor's office called to cancel the prescription. When taking out of pending inventory the PIC indicated the prescription was deleted instead of being placed on hold. The complainant did have a prescription filled at another pharmacy.

22-0427

Customer service issue related to courtesy, dignity, or respect; Duration of time to fill a prescription order; Medication not in stock, back ordered, or otherwise not immediately available.

A patient complained stating a pharmacist refused to give her her prescription. She stated the pharmacist scolded her like a child and finally gave her the medication. The pharmacist involved stated the store was very busy that day and they were behind. She stated she assured the patient the prescription would be filled in 15 minutes. After completing the fill, she gave the patient the medication at the drive through and attempted to counsel however the patient stated she knew all about it and denied counseling.

Customer service issue related to courtesy, dignity, or respect; Duration of time to fill a prescription order.

22-0428 A patient submitted a complaint against a pharmacy for unnecessary delays in automatic refills contributed by two open profiles under the same name. A second complaint was submitted stating that the medication was further delayed for special order without communication. A compliance officer reviewed the current patient profile and discovered an updated merged profile with no secondary accounts. The current patient profile accurately matched demographic and insurance records. Auto fill enrollment records showed that the medication in question is not system eligible by the computer and was unable to be set up. The medication was out of stock that caused delay in patient dispensing with an automated text message for customer service communication. At the time of delay the pharmacy was unable to transfer the unfilled controlled substance order. Pharmacy had a store level 30-day controlled substance fill policy with exemptions to allow a 2-day early fill, holidays, emergencies, and closures.

Customer service issue related to courtesy, dignity, or respect; Duration of time to fill a prescription order; Medication not in stock, back ordered, or otherwise not immediately available. 22-0430 A complainant alleged a prescription was not ready on the day she went for pick-up, and she was told to call the next day before 11:00 a.m. for the Duration of time to fill a prescription order; Use of professional prescription to be ready by 5:30 p.m. Per the complainant, the pharmacy needs to hire the amount of staff needed to handle prescriptions within two (2) hours of submission or close the pharmacy. The pharmacy practice coordinator indicated the complainant presented at 10:55 a.m. on 8/1/22 and requested a fill on both of her CII medications. The first was released to her at 12:35 p.m. that day. The second was filled and released the following day as it had a note from the doctor stipulating no

early fills.

Customer service issue related to courtesy, dignity, or respect; judgment to address a prescription order.

22-0433 A complainant alleged her Covid tests would be processed as a prescription, but the tests were then given to someone else. The Pharmacist-in-Charge ("PIC") indicated the complainant came to the pharmacy for a vaccination and also requested Covid OTC tests. The order for the tests was processed while the complainant filled out the form for the vaccination. The tests were prepared, bagged and sold in the system but the complainant left the pharmacy without receiving the tests. The bagged product was placed below the register in sold status, and then the package was broken down and product placed back on the shelf. Per the PIC the tests were not given to any other patient, and the complainant has since received the tests.

Payment or pricing related matters; Customer service issue related to courtesy, dignity, or respect.

22-0444 The complainant alleged they were unable to transfer a prescription due to the pharmacy refusing to answer their phones or return calls. The district manager was contacted by email and the prescription was transferred that day

Customer service issue related to courtesy, dignity, or respect.

A patient did not understand why a prescription that was written for 90 22-0446 tablets was filled for only 60 tablets. A prescription was sent electronically courtesy, dignity, or respect. to a pharmacy for Dexmethylphenidate Hydrochloride 10mg oral tablet, #90, with directions of "Take one tablet by mouth three times per day." A note on the prescription included, "Private pay with Good R.X.com." The patient alleged that he received only 60 tablets for \$84 when the prescription would have been free through insurance. A written statement from the pharmacist indicated that the patient's insurance would only cover twice daily dosing. The prescription was processed for 60 tablets for cash per the prescriber's instructions. Also, the prescriber was faxed a request by the pharmacy to obtain a prior authorization for the higher dosing and was told that the pharmacy did not cash out C2 prescriptions. A review of the controlled substances prescription monitoring program report found that the patient was covered by Medicaid.

Payment or pricing related matters; Customer service issue related to

A complaint was received from a patient involving an allegation of incompetence on the part of the pharmacy due to delays in the patient receiving their medication. The permit holder response stated the pharmacy received a faxed prescription for the patient. The prescription was input and rejected by insurance for "NDC not covered". The rejection stated another drug was covered, but only in cases of medical necessity. During this time the patient sent a digital message to the pharmacy providing drug discount card information to the pharmacy with a request to bill the patient for the discount card price. The patient was sent a response that the cost would be \$111.13 and that the order would require a scheduled delivery. Meanwhile the prescriber sent another prescription to the pharmacy for initial medication and subsequently issued a verbal order replacing the first medication with the covered medication. The medication was entered and rejected for a prior authorization ("PA") and while working to obtain a PA the pharmacy received another electronic prescription for the initial medication. The patient called concerning the status of their second order and was advised that a prior authorization was needed. The pharmacy now had two active prescriptions entered and contacted the prescriber to clarify which prescription their patient was to receive. The pharmacy advised the patient of the continued delay in not yet receiving a clarification on which drug to dispense from the patient's prescriber and the patient called stating than rather wait for the PA to be approved for the covered drug the patient would pay the cash price for the initial medication. The prescription was subsequently filled and shipped to the patient

22-0453

overnight.

A prescriber was upset that a patient attempted to fill a fraudulent prescription using his name/credentials. A pharmacy received a fax with two prescriptions and a suspect document from the Arizona Medical Board regarding a waiver of electronic prescription requirements. The prescriptions were for Phenergan w/Codeine syrup, 300mL, and Benzonatate 100mg cap, #21. The pharmacist on duty suspected that the prescriptions were forgeries. The prescriptions were not filled, and the pharmacist placed an alert in the pharmacy system regarding the forgery. A review of the controlled substance prescription monitoring program report found no results for the patient name on the prescriptions. Also, no prescriptions had been filled from this prescriber for Phenergan w/Codeine syrup during 2022.

Against an individual or entity over which the Board has no jurisdiction; Referred to the Office of Attorney General.

22-0454

A Doctor of Nursing Practice ("DNP") alleged a pharmacy inappropriately converted 30-day supply medication orders with two (2) refills into 90-day supplies. A compliance officer spoke to the DNP and discussed the legality and pharmaceutical feasibility of dispensing a drug per Arizona Administrative Code R4-23-402(A). The DNP agreed that Arizona laws do not prohibit a pharmacist, graduate intern, or pharmacy intern from dispensing multiple refills of a prescription when the prescription is initially filled or refilled as long as this manner is not contrary to the prescriber's directions. Pharmacist professional judgment was appropriately used in the complaint scenarios. Moving forward, the DNP will write specific notes on the prescription orders not to dispense a 90-day supply based on specific patient clinical needs.

Use of professional judgment to address a prescription order.

A complaint was received alleging an unlicensed pharmacist was working in a pharmacy. The complaint was opened on 8/11/2022 and compliance officers conducted a full compliance inspection of the pharmacy on 8/15 and 8/17/2022. The response from the Pharmacist-in-Charge ("PIC") stated a corporate trainer visited between 7/11 and 7/13/2022 and 7/18 and 7/22/2022 to perform clerical and training functions within the pharmacy. The trainer visited again from 8/3 to 8/12/2022 performing an interview of a new pharmacist candidate and auditing the work of another pharmacist. The PIC stated the trainer was a pharmacist licensed in Utah and Idaho, but not licensed in AZ. The PIC stated she was present in the pharmacy and the trainer was never alone in the pharmacy. The PIC stated the trainer ensured compliance with corporate SOP's, quality control, staff training and auditing of the pharmacy C2 perpetual inventory. The inspection of the pharmacy performed by the compliance officers did not observe evidence of an unlicensed pharmacist performing activities which would have required an AZ pharmacist license.

The allegations were investigated but not substantiated by available evidence. The investigation did not identify a possible violation of pharmacy law.

22-0462

The Board office received a complaint about the pharmacy routinely not having a medication in stock for the patient's chronic pain and insomnia medication. Thus, the patient had to pick up his medications at another location. The following month, the new location did not have his medication in stock either, and the patient had to go without medication. The Pharmacist-in-Charge ("PIC") stated the company implemented an CII electronic ordering system that does not allow her to order the CII medications for future prescriptions. Also, if the pharmacy staff receives and enters a prescription after the order cut-off time, then it will take an extra business day to arrive. She stated the past efforts to request changes in inventory par levels for CII medications, did not result in any improvement. One (1) prescription was transferred to another location that had it in stock because the wholesaler flagged the medication for long-term backorder, with no expected release date. The patient was notified of the transfer.

Customer service issue related to courtesy, dignity, or respect; Duration of time to fill a prescription order; Medication not in stock, back ordered, or otherwise not immediately available.

22-0463

The Board office received a complaint from a provider alleging that a pharmacist refused to administer a fifth dose of a COVID vaccine for her patient, in accordance with CDC guidelines. The provider became aware that the patient did not get the vaccine, because the patient notified the office. The provider also alleged that Pharmacist-in-Charge stated it was against the law and called the provider "stupid". The pharmacist stated he was not aware that a fifth dose was approved by the CDC for moderate-severely immunocompromised patients. He spoke with his district manager and she explained the updated guidelines. In addition, he printed the updated guidelines for reference, and held a meeting to ensure all of the staff was informed. He denied addressing the provider in a rude manner. During the investigation, the compliance officer did not find any medications in the patient's drug profile that indicated she was immunocompromised, only previous vaccinations.

Customer service issue related to courtesy, dignity, or respect; Use of professional judgment to address a prescription order.

The Board office received a complaint alleging a pharmacist refused to administer a fifth dose of a COVID vaccine to a patient, in accordance with professional judgment to address a prescription order. CDC guidelines. The patient stated that she had gone to same pharmacy for her other COVID vaccines, so she returned for again with a note from the provider for a fifth dose. She also stated the Pharmacist-in-Charge ("PIC") called the provider "stupid". She then called her provider to explain what happened at the pharmacy. The PIC stated he was not aware that a fifth dose was approved by the CDC for moderate-severely immunocompromised patients. He spoke with his district manager and she explained the updated guidelines. In addition, he printed the updated guidelines for reference, and held a meeting to ensure all of the staff was informed. He denied calling the provider "stupid". During the investigation, the compliance officer did not find any medications in the patient's drug profile that indicated she was immunocompromised, only previous vaccinations. The CO also noted this complaint is related to complaint # 22-0463.

Customer service issue related to courtesy, dignity, or respect; Use of

22-0477

A patient alleged that her prescription was short two (2) tablets and the pharmacist refused to provide the additional tablets. The pharmacist counted the on-hand balance of the medication and determined the count matched the computer balance. In addition, she viewed camera footage of the technician counting the tablets and was satisfied that it was counted correctly. The compliance officer conducted an audit of the medication. The audit resulted in a shortage of three (3) tablets. This result makes it impossible to determine if the prescription was shorted, but leans toward it having been counted correctly.

Allegations were investigated but could not be substantiated by available evidence. The investigation did not identify a violation of pharmacy law.

22-0481

A pharmacy is alleged to have disclosed impermissible and protected health information. The pharmacy staff is accused of unprofessional behavior and using inappropriate body language. A compliance officer spoke to the named individuals for additional details regarding disclosures of private patient information and unprofessional conduct. Staff had no added details to share and did not specifically recall the events mentioned on the date of the incident, a year ago. When asked about the unauthorized person receiving protected health information the staff indicated no knowledge of that individual. A name search of the unauthorized person was queried in the computer database and no matches were found. Patient profile notes were reviewed and specifically indicated that no authorized persons outside of the patient were to be communicated with.

Allegations were investigated but not substantiated by available evidence. The investigation did not identify a possible violation of pharmacy law.

A complaint was received concerning a delay in the mail pharmacy processing of a patient's Payment or pricing related matters; Customer service issue related to prescription. The complainant stated an order was placed with the pharmacy on 7/25/2022. The patient contacted the pharmacy's customer service due to concern with the shipping speed and was offered overnight delivery by the service agent. Two days later without receipt of the order the patient contacted customer service and was told the prescription was delayed due to an insurance issue. The patient was upset and contacted a local pharmacy to request the prescription be transferred from the mail to the local pharmacy. The patient stated the prescription was successfully transferred on 7/27/2022, however the local pharmacy subsequently could not fill the order. The patient requested the prescription be transferred to another local pharmacy on 7/28/2022 and that pharmacy was successful in filling the order. The patient stated another problem occurred when the prescription was refilled. The refill was rejected for a refill too soon alert which the complainant stated was caused by the original mail pharmacy. The patient stated the mail pharmacy made a fraudulent transaction as the original prescription was filled and not closed out after it was transferred. The Pharmacist-in-Charge ("PIC") stated a refill request for a prescription transfer was received online on 7/25/2022. The prescription was subsequently transferred from a pharmacy in California on 8/03/2022 to the respondent pharmacy. The PIC stated pharmacy records do not show comments pertaining to an inability to process the patient's prescription and confirmed the pharmacy accepts the patient's insurance plan. The prescription was delayed however due to a call being placed to the prescriber on 8/17/2022 to resolve a drug-drug interaction inquiry and after discussion with the prescriber the order was routed to the fulfillment pharmacy and shipped out to the patient on 8/18/2022. The PIC acknowledged the delay in processing the patient's prescription stating the pharmacy has been experiencing staffing challenges which have caused delays in filling prescriptions. The PIC stated the pharmacy has implemented an improved communications process to notify patients via email when a

A patient alleged that a pharmacist refused to fill her pain medication. The patient received two (2) narcotic prescriptions from a doctor who was Duration of time to fill a prescription order; Use of professional not her normal pain doctor. These prescriptions were filled, as they were from a surgeon. The patient then received two (2) prescriptions from her pain doctor for greater than her usually prescribed quantities. The pharmacist questioned the patient on the reason and was told it was none of her business. The pharmacist called the prescriber's office and waited for a return call to discuss with the pain doctor. The two prescriptions, which were written were ultimately filled within two (2)

Customer service issue related to courtesy, dignity, or respect; judgment to address a prescription order.

22-0349

An employee at a pharmacy filed a complaint with multiple unprofessional conduct allegations against the pharmacy, including that the pharmacy allowed a Covid-positive technician to compound; the pharmacy allows individuals who wear nail polish to compound; a pharmacist helps herself to antibiotics to treat sinus infections; and for at least a month, there has been a huge drip from the pipe in the ceiling with a garbage can collecting it. As soon as the pharmacy manager discovered that the pharmacy technician had Covid, she was placed on leave. The pharmacy manager and director, along with the Infection Control Nurse, followed the CDC guidelines and the technician was cleared to work. The current adopted USP version does not address nail polish. The compliance officer found no evidence of the pharmacist helping herself to antibiotics to treat sinus infections and the pharmacist denies having had a sinus infection. There was a drip from a pipe located in the pharmacy. The pharmacy monitored the humidity and temperature of the pharmacy until it could be fixed. The pharmacy noted that the temperature and humidity were always within range. There was a delay in obtaining the necessary parts due to a supply chain issue. The leak was successfully repaired.

Allegations were investigated but not substantiated by evidence. The investigation did not identify violations of pharmacy law.

22-0494 A pharmacy notified the Board that it terminated a pharmacist for unethical activities, including transcribing, processing, and checking/filling his own prescriptions, then selling them to himself outside of business hours. In written statements, the Respondent acknowledged the activities that led to his separation. Upon investigation, Board staff was unable to identify a possible violation of pharmacy law.

The allegations were investigated, and the investigation did not identify a possible violation of pharmacy law.

22-0419 A patient filed a complaint alleging that the pharmacist went against her doctor's medication recommendation and created an unnecessary barrier for her to pick up her prescription. The patient had been filling prescriptions at this pharmacy. The last fill was on 7/11/2022 for a 30-day supply. On 7/26/2022, the pharmacy received a prescription for a new medication. The patient never filled a prescription for that medication. Both medications are controlled substances (CII), and the pharmacist received a duplicate therapy DUR and, therefore, contacted the prescriber. This caused a delay in the patient receiving the prescription. According to the pharmacist, he needed to verify which medication the patient needed to be on and/or if she was to use both medications. Once the pharmacist received confirmation from the prescriber, he processed the prescription. The pharmacy employee listed by the complainant

22-0505 A patient filed a complaint because the pharmacy filled his prescription with a generic medication instead of the brand. The patient had been receiving a brand-name medication. Recently, the generic became available; therefore, the prescription is now filled with the generic substitution. The prescription did not state dispense as written (DAW), and an AB substitution is permissible.

Use of professional judgment to address a prescription order.

A complainant indicated she is immunocompromised and she felt unsafe when she had to enter a pharmacy when the drive through was closed. In addition, she indicated the pharmacy is only open five (5) days per week and this is a burden for workers. The pharmacy is open 9am-5pm, Monday through Friday, it is closed on the weekends and for lunch. There is nothing in statute or rule for use of a drive through or operational hours of a community pharmacy. The complaint was forwarded to the pharmacy District Manager.

Customer service issue related to courtesy, dignity, or respect.

A complainant forwarded information obtained from a neighborhood forum concerning a refill of a medication at a pharmacy. The complainant is not listed in the forum queue so does not appear to have any direct concerns with the pharmacy. No specific consumer complaints have been filed. The information was forwarded to the District Manager.

Customer service issue related to courtesy, dignity, or respect.

2022-36 A medical doctor alleged a pharmacy corporation banned him from prescribing all controlled substances for no reason. The complainant filed previously with the Board for the same issue. The complainant indicated the Board has not responded to this egregious act against his practice of medicine, however Board records indicate a resolution letter was sent to the complainant. The complainant indicated the pharmacy corporation refused to fill any of his controlled substances without giving a reason or an explanation. The corporate response included a copy of the letter provided to the complainant. Previous responses and SOP for refusals to fill, blanket refusals to fill, and centrally blocked prescribers are on file for the prior complaint.

Use of professional judgment to address a prescription order.

2022-37 An individual alleged a supply issue at pharmacies in her area for brand Zoloft and the Aurobindo generic and wanted to know how they could be made available in Arizona. The individual did not want to file a complaint as she indicated it was not a specific pharmacy issue, she was looking for the Board to work with the FDA to fix the supply issue. She indicated she was aware of a manufacturer issue as multiple pharmacies had attempted to purchase the drugs. The individual was provided with the number of the Consumer Complaint Coordinator listed on the FDA site and also the MedWatch information.

Medication not in stock, back ordered, or otherwise not immediately available; Allegations were investigated, and the investigation did not identify a violation of pharmacy law.
