9 Pursuant to Notice of Hearing Number 00-0016-PHR ("Notice") this matter came before the  
10 Arizona State Board of Pharmacy ("Board") on November 9, 2000.

11 Susan V. Ford, president, presided with members Gerald G. Ritt, Daniel Ketcherside, William  
12 E. Jones, Dennis McAllister, Paul Draugalis and Eugene Drake in attendance.

13 The State was represented by the Office of the Attorney General, Nancy Beck, Assistant Attorney  
14 General, Licensing and Enforcement Section, the Board was represented by Thomas Dennis, who was  
15 available by telephone.

16 The respondent KAREN D. LIEB was not present and was not represented by counsel. The  
17 Board, after consideration of the evidence and testimony presented, hereby makes the following Findings  
18 of Fact and Conclusions of Law.

19 **FINDINGS OF FACT**

20 **I**

21 1. The Arizona State Board of Pharmacy is that body created and empowered pursuant to A.R.S.  
22 § 32-1904 to administer the laws of the State of Arizona relating to the practice of pharmacy.

23 2. KAREN D. LIEB is the holder of Certificate of Registration Number 8619 issued by the  
24 Arizona State Board of Pharmacy which permits the holder to practice pharmacy in the State of Arizona.

25 3. The evidence and testimony presented in this matter sustained the factual allegations in the  
26 Notice. The Board finds that KAREN D. LIEB has violated her Pharmacists Assisting Pharmacists of

1 Arizona (PAPA) contract by failing to name her counselor to PAPA staff and Board Order Number 99-  
2 0032-PHR, dated January 13, 2000.

3 **CONCLUSIONS OF LAW**

4 **II**

5 1. The Board has jurisdiction in this matter pursuant to paragraph thirteen (13) of Board Order  
6 Number 99-0032-PHR, dated January 13, 2000.

7 2. The Board concludes that KAREN D. LIEB has violated her Pharmacists Assisting Pharmacists  
8 of Arizona (PAPA) contract and Board Order Number 99-0032-PHR, dated January 13, 2000.

9 **ORDER**

10 **III**

11 The Certificate of Registration Number 8619 issued to KAREN D. LIEB is hereby revoked.


12 KAREN D. LIEB has the right to request a rehearing or review of this decision. A request for a  
13 rehearing or review of this decision shall be in writing and satisfy the prerequisites of A.A.C. R4-23-  
14 109(D). In order to be eligible for judicial review pursuant to Title 12, Chapter 7, Article 6, KAREN D.  
15 LIEB is required to exhaust her administrative remedies by filing a motion for rehearing or review within  
16 thirty days after service of these Findings of Fact, Conclusions of Law and Order of Probation. Pursuant  
17 to A.R.S. § 41-1092.09(B), KAREN D. LIEB is notified that failure to file a motion for rehearing or  
18 review within thirty days after service of these Findings of Fact, Conclusions of Law and Order of  
19 Probation has the effect of prohibiting her from seeking judicial review of the Board's decision. Service  
20 is complete on personal service or five days after the date these Findings of Fact, Conclusions of Law and  
21 Order of Revocation are mailed to your last known address.
