**FINDINGS OF FACT, CONCLUSIONS
of LAW and ORDER NO. 08-0040-PHR**

On November 13th, 2008 the Arizona State Board of Pharmacy ("Board") considered the State's Motion to Deem Allegations Admitted at the Board of Pharmacy Offices, 1700 W. Washington Street, Room 312, in Phoenix, Arizona. Elizabeth Campbell, Assistant Attorney General, appeared on behalf of the State. Respondent did not appear.

On November 13th, 2008 the Board granted the State's Motion to Deem Allegations Admitted. Based upon A.R.S. § 32-1927.01(O) and the Complaint and Notice of Hearing No. 08-0040-PHR filed in this matter, the Board issues the following Findings of Fact and Conclusions of Law, and Order revoking Respondent's license.

FINDINGS OF FACT

1. At all times relevant to this matter, Respondent was employed by Phoenix Children's Hospital in Phoenix, Arizona.

2. On or about January 15, 2008, Respondent's employer requested that Respondent take a "reasonable suspicion" drug test. Respondent tested positive for marijuana on that drug test. Respondent was terminated from employment.

CONCLUSIONS of LAW

1. The Board possesses jurisdiction over the subject matter and over Respondent under A.R.S. § 32-1901 *et seq.*


1 rehearing is not filed, the Board's Order becomes effective thirty-five (35) days after it is mailed to
