10 Pursuant to Notice of Hearing Number 09-0008-PHR (Notice) this matter came before the  
11 Arizona State Board of Pharmacy (Board) on November 19, 2009.

13 Dennis McAllister, president, presided with members Zina Berry, JoAnne Galindo, Steve  
14 Haiber, Louanne Honeyestewa, Daniel Milovich, Ridge Smidt, and Tom Van Hassel in attendance.

15 The State was represented by the Office of the Attorney General, Elizabeth Campbell,  
16 Assistant Attorney General, Licensing and Enforcement Section. Mary Jo Foster, of the Solicitor  
17 General's Section of the Attorney General's Office was present and available to provide independent  
18 legal advice to the Board. Dorsa Gariba was not present and was not represented by an attorney.

20 The Board, after considering the testimony and evidence presented, hereby issues the following  
21 Findings of Fact, Conclusions of Law, and Order.

22 **FINDINGS OF FACT**

24 1. In an attempt to acquire a portion of the 1500 internship training hours required for  
25 licensure under Arizona Administrative Code R4-23-303, Respondent worked as a pharmacy intern at  
26 the Avondale Neighborhood Pharmacy (the "Pharmacy") in Avondale, Arizona for several months in
