**FINDINGS OF FACT, CONCLUSIONS**  
**of LAW and BOARD ORDER**  
**No. 10-00-71-PHR**

11 Pursuant to Notice of Hearing Number 10-0071-PHR (Notice) this matter came before  
12 the Arizona State Board of Pharmacy (Board) on September 16th, 2010.

13  
14 Zina Berry, president, presided with members James Foy, JoAnne Galindo, Dennis  
15 McAllister, Dan Milovich, Steve Haiber, Kyra Locnikar, Louanne Honeyestewa and Tom Van  
16 Hassel in attendance.

17  
18 The State was represented by the Office of the Attorney General, Elizabeth Campbell,  
19 Assistant Attorney General, Licensing and Enforcement Section. Mary Jo Foster, of the  
20 Solicitor General's Section of the Attorney General's Office was present to provide  
21 independent legal advice to the Board. Deborah Grabowski Chenoweth, (Respondent) was not  
22 present and was not represented by an attorney. The Board, after considering the testimony  
23 and evidence presented, hereby issues the following Findings of Fact, Conclusions of Law,  
24 and Order.

1 **FINDINGS of FACT**

2 1. Following a formal hearing, the Board issued Findings of Fact, Conclusions of  
3 Law and Order in Board Case No. 08-0053-PHR (the "Board Order"). The Board  
4 Order became effective on December 24, 2008.

5  
6 2. The Board Order required that Respondent pay a civil penalty of \$3,000 along  
7 with \$1,250 for the costs of the Board's proceedings. Respondent was required to pay  
8 the civil penalty and costs within 180 days from the date of the Board Order.

9  
10 3. Respondent has failed to pay the money due pursuant to the Board Order.

11 **CONCLUSIONS of LAW**

12  
13 1. The Board may discipline a pharmacist who has engaged in unprofessional  
14 conduct. A.R.S. § 32-1927(A)(1).

15  
16 2. The conduct and circumstances described above constitutes unprofessional  
17 conduct pursuant to A.R.S. § 32-1901.01(B)(20) (Violating a formal order, terms of  
18 probation, a consent agreement or a stipulation issued or entered into by the Board or its  
19 executive director).

20 **ORDER**

21  
22 In view of the above Findings of Fact and Conclusions of Law, the Board issues the  
23 following Order:


24 The pharmacist license issued to Deborah Grabowski Chenoweth is revoked.

25 **RIGHT TO PETITION FOR REHEARING OR REVIEW**

26  
27 Respondent is hereby notified of the right to petition for a rehearing or review by filing  
28 a petition with the Board's Executive Director within thirty (30) days after service of this  
29

1 Order. A.R.S. § 41-1092.09. The petition must set forth legally sufficient reasons for granting  
2 a rehearing. A.C.C. R4-23-128. Service of this order is effective five (5) days after date of  
3 mailing. If a motion for rehearing is not filed, the Board's Order becomes effective thirty-five  
4 (35) days after it is mailed to Respondent.  
5

6 Respondent is further notified that the filing of a motion for rehearing is required to  
7 preserve any rights of appeal to the Superior Court.
