JURISDICTION

For the reasons stated hereinbelow, and pursuant to A.R.S. § 32-1928 the Board of Pharmacy will conduct a hearing at 1:00 p.m., the 8th day of December, 1987, at the Tempe Inn Suites, 1651 W. Baseline Rd., Tempe, Arizona to determine whether or not Certificate of Registration No. 5785 issued to MARTIN D. JACOBS should be revoked, suspended, or placed on probation, censured or fined.

PARTIES

The Arizona State Board of Pharmacy is that body created and empowered pursuant to A.R.S. § 32-1904 to administer the laws of the State of Arizona relating to the practice of pharmacy.

MARTIN D. JACOBS is the holder of Certificate of Registration No. 5785 which allows him to engage in the practice of Pharmacy in the State of Arizona

6 to marijuana, prescription-only drugs, narcotics, dangerous drugs or controlled

16 in this Notice of Hearing and present testimony and argument in support of
17 his defense with respect to the assertions contained in this Notice of
18 Hearing.

19 If the respondent fails to appear, the Board may proceed and determine
20 the matter in his absence.

21 MARTIN D. JACOBS is further notified that no continuance will be
22 granted unless a request for continuance is submitted to the Board in
23 writing, detailing the reasons for the requested continuance, and that
24 request is granted by the Board. Except in the event of an emergency, a
