9 This matter came before the Arizona State Board of Pharmacy for hearing  
10 on the 28th day of September, 1988, pursuant to Complaint and Notice of Hearing  
11 No. 88-8-H (hereinafter referred to as "Complaint"), attached to and made  
12 part of this Order. Norma McConnell, president, presided and members Danny  
13 Jacob, Sumner "Al" Brooks, Edward Saba, Martha Barron and Linda Tansik were in  
14 attendance and participating therein.

15 The State was represented by the office of the Attorney General, Montgomery  
16 Lee, Assistant Attorney General. The Respondent, ROBERT PAUL BROWER II was  
17 present and represented by counsel, Karl D. Elledge, Attorney.

18 The Board, after consideration of the evidence and testimony presented,  
19 hereby makes the the following Findings of Fact, Conclusions of Law and  
20 Order.

22 FINDINGS OF FACT

23 I

24 ROBERT PAUL BROWER is a pharmacist holding Certificate of Registration  
25 No. 6995 issued by the Board pursuant to A.R.S. § 32-1922.

2 Evidence was presented, including testimony by Robert Paul Brower II and  
3 James N. Threadgill, Compliance Officer for the Arizona State Board of Pharmacy.

5 CONCLUSIONS OF LAW

7 That the Findings of Fact set forth herein above constitute sufficient  
8 evidence to find that ROBERT PAUL BROWER II is in violation of those State and  
9 Federal laws, rules and regulations contained in paragraph IV of the  
10 Complaint.

13 The above described action constitutes grounds for discipline pursuant to  
14 A.R.S. § 32-1927.A.

18 In view of the above Findings of Fact and Conclusions of Law, the Board  
19 hereby issues the following Order:

20 1. That the Certificate of Registration No. 6995 issued to ROBERT PAUL  
21 BROWER II be revoked effective September 28, 1988.


23 2. On or after September 27, 1990, ROBERT PAUL BROWER II may request an  
24 appearance before the Arizona State Board of Pharmacy to show cause why  
25 Certificate of Registration No. 6995 should be reinstated. At that time ROBERT  
26 PAUL BROWER II would be subject to such stipulations as the Board might impose.

1 ROBERT PAUL BROWER II is hereby notified he has the right to petition this  
2 Board for a rehearing within ten (10) days after receipt of this Order pursuant  
3 to the provisions of Administrative Rule R4-23-109.D.1
