This Matter came before the Arizona State Board of Pharmacy on the 29th day of January, 1993 pursuant to a request by the Respondent, petitioning the Arizona State Board of Pharmacy to remove the suspension imposed in the Matter of 88-09-H and further to impose a probation commencing, retroactively to the 30th day of April, 1992 and continuing until at least April 30, 1995. Daniel J. Jacob, president presided, with Michael Noel, vice-president and members Gerald R. Ritt, Kathryn L. Kalsman, Perry D. Don and John Harrington in attendance and participating therein.

After consideration of the request and review of the Consent order issued in Illinois on April 30, 1992 the Board unanimously agreed to remove the suspension, effective retroactively to the 30th of April, 1992 and impose probation commencing on the 30th day of April, 1992 and continuing to, at least the 30th day of April, 1995. Said probation would include the same conditions imposed in Illinois and found in 87-1161 dated April 30th, 1992 and issued by the Illinois Board of Pharmacy and attached hereto.

NICHOLAS ARMAND D'ANDREA shall appear before the Arizona State Board of Pharmacy on or after April 30th, 1995 to show cause that
