8 Pursuant to the foregoing Consent to Entry of Order, the  
 9 evidence and records compiled and contained in the file for  
 10 JAMES C. CHURCHILL and for good cause appearing, the Board on this  
 11 9th day of July, 1992 enters the following Finding of Fact,  
 12 Conclusions of Law and Board Order in the Matter of 92-11-H.

FINDINGS OF FACT

I

 14 1. JAMES C. CHURCHILL is the holder of Certificate of  
 15 Registration Number 6085 issued by the Arizona State Board of  
 16 Pharmacy which permits the holder to practice pharmacy in the State  
 17 of Arizona.

18 2. That on the 30th day of June, 1992, JAMES C. CHURCHILL  
 19 did enter into a Consent to Entry of Order with the Arizona State  
 20 Board of Pharmacy admitting that factual allegations contained in  
 21 the Notice of Hearing Number 92-11-H are true and accurate.

22 3. That JAMES C. CHURCHILL admits to violations of A.A.C. §  
 23 R4-23-204(D)(1) to wit: failure to produce original certificates  
 24 verifying participation in twenty (20) hours of Continuing  
 25 Education indicated on the application dated June 24, 1991 for  
 26

2 renewal of Certificate of Registration Number 6085 pursuant to  
3 A.R.S. § 32-1936.

4 4. JAMES C. CHURCHILL is aware of the fact that the conduct  
5 contained in the factual allegations constitutes grounds for  
6 disciplinary action as provided for in A.R.S. § 32-1927(A)(10) and  
7 A.R.S. § 32-1927(B)(2).

8 CONCLUSIONS OF LAW

10 1. The Board concludes that it has jurisdiction in this  
11 Matter pursuant to A.R.S. § 32-1927 (A)(10) and 32-1927(B)(2).

12 2. The Board concludes that JAMES C. CHURCHILL did violate  
13 A.A.C. § R4-23-204(D)(1) to wit: failure to produce original  
14 certificates verifying participation in twenty (20) hours of  
15 Approved Continuing Education indicated on the application dated  
16 June 24, 1991 for the renewal of Certificate of Registration  
17 Number 6085 pursuant to A.R.S. § 32-1936.

18 3. The Board further concludes that JAMES C. CHURCHILL  
19 is in violation of A.R.S. § 32-1927(A)(10) and 32-1927(B)(2).

22 The certificate of Registration Number 6085 issued to  
23 JAMES C. CHURCHILL is placed on probation for two years commencing  
24 ten (10) days from the date of this Order. The probation imposed  
25 by this Order may be removed subject to the following conditions:

1. JAMES C. CHURCHILL shall pay a one-hundred (\$100.00) civil penalty to the Board within 60 days of the date of the Order.

2. JAMES C. CHURCHILL shall complete thirty (30) hours of ACPE Approved Continuing Education with one year of the date of this Order. Said hours shall apply only to the failure on this Order and shall not be applied to subsequent renewals.

3. Respondent shall pay all fees and complete all Continuing Education requirements throught the term of probation to maintain Certificate of Registration Number 6085.

4. Respondent shall obey all the laws and rules governing the practice of pharmacy.


5. Respondent shall appear before the Arizona State Board of Pharmacy to request a removal of probation upon completion of the conditions outlined in numbers 1. and 2. above.

6. If the Respondent violates this Order in any way or fails to fullfill the requirements of this Order, the Board, after giving the Respondent Notice and the opportunity to be heard, may revoke, suspend or take other disciplinary action against the Respondent.
