 9 SALVATORE CIARAMETARO and for good cause appearing, the Board on  
 10 this 30th day of March, 1995 enters the following Finding of Fact,  
 11 Conclusions of Law and Board Order in the Matter of 95-03-H.

FINDINGS OF FACT

14 1. SALVATORE CIARAMETARO is the holder of Certificate of  
 15 Registration Number 9653 issued by the Arizona State Board of  
 16 Pharmacy which permits the holder to practice pharmacy in the State  
 17 of Arizona.

18 2. That on the 1st day of February, 1995 SALVATORE  
 19 CIARAMETARO did enter into a Consent to Entry of Order with the  
 20 Arizona State Board of Pharmacy admitting that factual allegations  
 21 contained in the Notice of Hearing Number 95-03-H are true and  
 22 accurate.

23 3. That SALVATORE CIARAMETARO admits to violations of A.A.C. S  
 24 R4-23-402.B, to wit:  
 25 failure to provide oral communication when directly dispensing  
 26 a new prescription.

1 conduct contained in the factual allegations constitutes grounds for  
2 disciplinary action as provided for in A.R.S. § 32-1927(A)(10) and  
3 A.R.S. § 32-1927(B)(2).

4 CONCLUSIONS OF LAW

6 1. The Board concludes that it has jurisdiction in this Matter  
7 pursuant to A.R.S. § 32-1927 (A)(10) and 32-1927(B)(2).

8 2. The Board concludes that SALVATORE CIARAMETARO did violate  
9 A.A.C. § R4-23-402.B, to wit:

10 failure to provide oral communication when directly dispensing  
11 a new prescription.

12 3. The Board further concludes that SALVATORE CIARAMETARO is  
13 in violation of A.R.S. § 32-1927(A)(10) and 32-1927(B)(2).

14 ORDER

16 The certificate of Registration Number 9653 issued to  
17 SALVATORE CIARAMETARO is hereby placed on probation for a period of  
18 two (2) years effective 10 days from the date of this Order, and  
19 continuing to at least March 30, 1997. The probation imposed by this  
20 Order may be removed subject to the following conditions:

21 1. SALVATORE CIARAMETARO shall pay a one-hundred (\$100.00)  
22 dollar civil penalty to the Board of Pharmacy within 60 days of the  
23 date of this Order.

24 2. SALVATORE CIARAMETARO shall complete eight (8) hours of  
25 Continuing Education within one year of the date of this Order. Said  
26 hours shall consist of the two part (4 hours each) titled

1 Pharmacist-Patient Consultation Program or an alternative program  
2 approved by the Board and shall apply only to the failure on this  
3 Order and shall not be applied to subsequent renewals.

4 3. SALVATORE CIARAMETARO shall pay all fees and complete all  
5 Continuing Education requirements throughout the term of probation  
6 to maintain Certificate of Registration Number 5013.

7 4. SALVATORE CIARAMETARO shall obey all federal and state laws  
8 and rules governing the practice of pharmacy.

9 5. SALVATORE CIARAMETARO shall appear before the Arizona State  
10 Board of Pharmacy to request a removal of probation upon completion  
11 of the conditions outlined in paragraphs 1. and 2. above.

12 6. If SALVATORE CIARAMETARO violates this Order in any way or  
13 fails to fulfill the requirements of this Order, the Board, after  
14 giving the Respondent Notice and the opportunity to be heard, may  
15 revoke, suspend or take other disciplinary action against the  
16 Respondent.
