9 Pursuant to the foregoing Consent to Entry of Order, the evidence
10 and records compiled and contained in the file for
11 CHRISTOPHER J. LeFAVE and for good cause appearing, the Board on this
12 16th day of November, 1995 enters the following Finding of Fact,
13 Conclusions of Law and Board Order in the Matter of
14 95-19-H.

15 FINDINGS OF FACT

16 I

17 1. CHRISTOPHER J. LeFAVE is the holder of Certificate of
18 Registration Number 9797 issued by the Arizona State Board of Pharmacy
19 which permits the holder to practice pharmacy in the State of Arizona.

20 2. That on the 13th day of October, 1995, CHRISTOPHER J. LeFAVE
21 did enter into a Consent to Entry of Order with the Arizona State
22 Board of Pharmacy admitting that factual allegations contained in the
23 Notice of Hearing Number 95-19-H are true and accurate.

24 3. That CHRISTOPHER J. LeFAVE admits to violations of A.A.C. §
25 R4-23-204(D)(1) to wit: failure to produce original certificates
26 verifying participation in 16 hours of Continuing Education

1 for the period July 1, 1993 to June 30, 1995 as required for renewal
2 of Certificate of Registration Number 9797 pursuant to A.R.S. § 32-
3 1936.

4 4. That CHRISTOPHER J. LeFAVE is aware of the fact that the
5 conduct contained in the factual allegations constitutes grounds for
6 disciplinary action as provided for in A.R.S. § 32-1927(A)(10) and
7 A.R.S. § 32-1927(B)(2).

8 CONCLUSIONS OF LAW

9 II

10 1. The Board concludes that it has jurisdiction in this Matter
11 pursuant to A.R.S. § 32-1927 (A)(10) and 32-1927(B)(2).

12 2. The Board concludes that CHRISTOPHER J. LeFAVE did violate
13 A.A.C. § R4-23-204(D)(1) to wit: failure to produce original
14 certificates verifying participation in 16 hours of Approved
15 Continuing Education for the period July 1, 1993 to June 30, 1995 as
16 required for the renewal of Certificate of Registration Number 9797
17 pursuant to A.R.S. § 32-1936.

18 3. The Board further concludes that CHRISTOPHER J. LeFAVE is in
19 violation of A.R.S. § 32-1927(A)(10) and 32-1927(B)(2).

20 ORDER

21 III

22 The certificate of Registration Number 9797 issued to CHRISTOPHER
23 J. LeFAVE is placed on probation for two years commencing ten (10)
24 days from the date of this Order. The probation may be vacated
25 subject to the following conditions:
26

1 1. CHRISTOPHER J. LeFAVE shall pay a one-hundred (\$100.00) civil
2 penalty to the Board within 60 days of the date of the Order.

3 2. CHRISTOPHER J. LeFAVE shall complete fifteen (15) hours of
4 ACPE Approved Continuing Education within one (1) year of the date of
5 this Order. Said hours shall apply only to the failure on this Order
6 and shall not be applied to subsequent renewals.

7 3. CHRISTOPHER J. LeFAVE shall pay all fees and complete all
8 Continuing Education requirements throughout the term of probation to
9 maintain Certificate of Registration Number 9797.

10 4. CHRISTOPHER J. LeFAVE shall obey all the laws and rules
11 governing the practice of pharmacy.

12 5. CHRISTOPHER J. LeFAVE shall appear before the Arizona State
13 Board of Pharmacy or petition the board in writing to vacate the
14 probation upon completion of the conditions outlined in paragraphs 1.
15 and 2. above.

16 6. If CHRISTOPHER J. LeFAVE violates this Order in any way or
17 fails to fulfill the requirements of this Order, the Board, after
18 giving the Respondent Notice and the opportunity to be heard, may
19 revoke, suspend or take other disciplinary action against the
20 Respondent.
