9 Pursuant to the foregoing Consent to Entry of Order, the evidence
10 and records compiled and contained in the file for DEBRA A. HOLLINGER
11 and for good cause appearing, the Board on this 12th day of November,
12 1997 enters the following Finding of Fact, Conclusions of Law and
13 Board Order in the Matter of Notice of Hearing 97-0015-H.

14 FINDINGS OF FACT

15 I

16 1. DEBRA A. HOLLINGER is the holder of Certificate of
17 Registration Number 8107 issued by the Arizona State Board of Pharmacy
18 which permits the holder to practice pharmacy in the State of Arizona.

19 2. That on the 23rd day of October, 1997, DEBRA A. HOLLINGER did
20 enter into a Consent to Entry of Order with the Arizona State Board of
21 Pharmacy admitting that factual allegations contained in the Notice of
22 Hearing Number 97-0015-H are true and accurate.

23 3. That DEBRA A. HOLLINGER admits to violations of A.A.C. § R4-
24 23-204(D)(1) to wit: failure to produce original certificates
25 verifying participation in 23 hours of Continuing Education for the
26 period July 1, 1995 to June 30, 1997 as required for renewal of

1 Certificate of Registration Number 8107 pursuant to A.R.S. § 32-1936.

2 4. That DEBRA A. HOLLINGER is aware of the fact that the conduct
3 contained in the factual allegations constitutes grounds for
4 disciplinary action as provided for in A.R.S. § 32-1927(A)(10).

5 CONCLUSIONS OF LAW

6 II

7 1. The Board concludes that it has jurisdiction in this Matter
8 pursuant to A.R.S. § 32-1927 (A)(10) and 32-1925(G).

9 2. The Board concludes that DEBRA A. HOLLINGER did violate
10 A.A.C. § R4-23-204(D)(1) to wit: failure to produce original
11 certificates verifying participation in 23 hours of Approved
12 Continuing Education for the period July 1, 1995 to June 30, 1997 as
13 required for the renewal of Certificate of Registration Number 8107
14 pursuant to A.R.S. § 32-1936.

15 3. The Board further concludes that DEBRA A. HOLLINGER is in
16 violation of A.R.S. § 32-1927(A)(10).

17 ORDER

18 III

19 The certificate of Registration Number 8107 issued to DEBRA A.
20 HOLLINGER is placed on probation for two years commencing ten (10)
21 days from the date of this Order. The probation may be vacated
22 subject to the following conditions:

23 1. DEBRA A. HOLLINGER shall pay a one-hundred (\$100.00) civil
24 penalty to the Board within 60 days of the date of the Order.

25 2. DEBRA A. HOLLINGER shall complete thirty-four (34) hours of
26 ACPE Approved Continuing Education within one (1) year of the date of

1 this Order. Said hours shall apply only to the failure on this Order
2 and shall not be applied to subsequent renewals.

3 3. DEBRA A. HOLLINGER shall pay all fees and complete all
4 Continuing Education requirements throughout the term of probation to
5 maintain Certificate of Registration Number 8107.

6 4. DEBRA A. HOLLINGER shall obey all the laws and rules
7 governing the practice of pharmacy.

8 5. DEBRA A. HOLLINGER shall appear before the Arizona State
9 Board of Pharmacy or petition the board in writing to vacate the
10 probation upon completion of the conditions outlined in paragraphs 1.
11 and 2. above.

12 6. If DEBRA A. HOLLINGER violates this Order in any way or fails
13 to fulfill the requirements of this Order, the Board, after giving the
14 Respondent Notice and the opportunity to be heard, may revoke, suspend
15 or take other disciplinary action against the Respondent.
