10 Pursuant to the foregoing Consent to Entry of Order, the evidence
 11 and records compiled and contained in the file for MARK A. HOLLINGER
 12 and for good cause appearing, the Board on this 12th day of March,
 13 1998 enters the following Finding of Fact, Conclusions of Law and
 14 Board Order.

14 FINDINGS OF FACT

15 I

16 1. MARK A. HOLLINGER is the holder of Certificate of Registration
 17 Number 8335 issued by the Arizona State Board of Pharmacy which
 18 permits the holder to practice pharmacy in the State of Arizona.

19 2. MARK A. HOLLINGER voluntarily surrendered Certificate of
 20 Registration Number 8335 on or about June 24, 1994.

21 3. MARK A. HOLLINGER is contracted to the Pharmacists Assisting
 22 Pharmacists in Arizona (PAPA) program, a program that treats and
 23 rehabilitates pharmacists who are or have been impaired by alcohol or
 24 drug abuse.

25 4. MARK A. HOLLINGER neither admits or denies that he violated
 26 A.R.S. § 32-1927 (A) (10) to wit:

2 The licensee is found by the board to be guilty of violating
3 any Arizona or federal law rule or regulation relating to the
4 manufacture and distribution of drugs, and devices or the
5 practice of pharmacy.

6 and A.R.S. § 32-1927 (B) (2), to wit:

7 The licensee is found by the board, or is convicted in a federal
8 or state court, of having violated federal or state laws or
9 administrative rules pertaining to marijuana, prescription-only
10 drugs, narcotics, dangerous drugs or controlled substances.

11 CONCLUSIONS OF LAW

12 II

13 1. The Board concludes that it has jurisdiction in this Matter
14 pursuant to A.R.S. § 32-1927(A)(10) and A.R.S. § 32-1927(B)(2).

15 2. The Board concludes that MARK A. HOLLINGER did violate A.R.S.
16 § 32-1927(A)(10), and A.R.S. § 32-1927(B)(2) prior to July 5th, 1993.

17 ORDER

18 III

19 The Certificate of Registration Number 8335 issued to MARK A.
20 HOLLINGER is hereby placed on probation until the 15th day of January,
21 1999, commencing ten (10) days from the date of this Order. The
22 probation is subject to the following conditions:

23 1. MARK A. HOLLINGER shall pay all fees and complete all
24 Continuing Education requirements throughout the term of probation to
25 maintain Certificate of Registration Number 8335.

26 2. MARK A. HOLLINGER shall obey all federal and state laws and
rules governing the practice of pharmacy.

3. MARK A. HOLLINGER is required to furnish any and all pharmacy

1 employers with a copy of this board Order throughout the term of
2 probation.

3 4. MARK A. HOLLINGER shall maintain his current contract for
4 treatment and rehabilitation with the PAPA program for the duration of
5 the five (5) year term and he shall comply with each and every
6 requirement of that contract.

7 5. MARK A. HOLLINGER shall appear before the Arizona State Board
8 of Pharmacy on or after the 15th day of January, 1999 to request a
9 removal of probation.

10 6. If MARK A. HOLLINGER violates this Order in any way or fails
11 to fulfill the requirements of this Order, the Board, after giving the
12 Respondent Notice and the opportunity to be heard, may revoke, suspend
13 or take other disciplinary action against the Respondent.
