21 permits the holder to operate a wholesale business in the State of Arizona.


22 2. Paragraphs one (1) and two (2) of the Notice of Hearing Number 99-027-PHR allege that
23 violations of the Arizona Pharmacy Act occurred, and are grounds for disciplinary action as defined in
24 A.R.S. § 32-1932(A), and A.A.C. R4-23-605(B).
