

NOTICE

Due to a change in statute, the Board of Pharmacy will begin requiring fingerprint clearance cards in August 2016. To facilitate the changeover from fingerprint cards to clearance cards, we will stop accepting fingerprint cards at the close of business on **July 15, 2016**.

If you have not submitted your fingerprint packet (fingerprint card, verification form and \$22.00 check or money order) by **July 15, 2016**, you will be required to submit a fingerprint clearance card to complete your application. There will be NO exceptions to this requirement.

The fingerprint clearance card effective date will be posted on our website (<https://pharmacy.az.gov/>). DO NOT apply for a fingerprint clearance card prior to the effective date.

PTCB Certified Pharmacy Technician Licensure Requirements
(All pharmacy technician applicants MUST be at least 18 years of age)

All PTCB certified technician applicants must submit:

1. A completed application and fee (see fee chart below).
2. Proof of legal residency (please provide one (1) of the following) :
 - An Arizona driver license issued after 1996 or an Arizona non-operating identification license.
 - A driver license issued by a state that verifies lawful presence in the United States.
 - A birth certificate or delayed birth certificate issued in any state, territory or possession of the United States.
 - A United States certificate of birth abroad.
 - A United States passport. ***Passport must be signed***
 - A foreign passport with a United States visa.
 - An I-94 form with a photograph.
 - A United States citizenship and immigration services employment authorization document or refugee travel document.
 - A United States certificate of naturalization.
 - A United States certificate of citizenship.
 - A tribal certificate of Indian blood.
 - A tribal or bureau of Indian affairs affidavit of birth.
 - Any other license that is issued by the federal government, any other state government, an agency of this state or a political subdivision of this state that requires proof of citizenship or lawful alien status before issuing the license.
3. A copy of a government-issued photo identification (please provide one (1) of the following).
 - Driver license
 - State ID
 - Passport or Passport Card
4. Proof of PTCB Certification (please provide one (1) of the following):
 - PTCB Certificate
 - PTCB Wall Card
 - Letter of Passing Score from PTCB
5. If applicable, court records relating to any criminal charges or convictions, even if the charge or conviction was later dismissed, expunged or set aside.
6. Documentation of any name changes.

PTCB certified technician application fees are pro-rated. These fees **do not** include the \$22.00 fingerprint processing fee. The fees below may be paid by debit or credit card online. If you wish to pay by check or money order you may apply by mail or in person. The fingerprint processing fee MUST be paid by check or money order. It cannot be paid online. Application fees are NON-REFUNDABLE.
