

PTCB Certified Pharmacy Technician Licensure Requirements

(All pharmacy technician applicants MUST be at least 18 years of age)

All PTCB certified technician applicants must submit:

1. A completed application and fee (see below).
2. Proof of legal residency and birth date. Please provide one (1) of the following:
 - An Arizona driver license issued after 1996 or an Arizona non-operating identification license.
 - A driver license issued by a state that verifies lawful presence in the United States.
 - A birth certificate or delayed birth certificate issued in any state, territory or possession of the United States.
 - A United States certificate of birth abroad.
 - A United States passport. ***Passport must be signed***
 - A foreign passport with a United States visa.
 - An I-94 form with a photograph.
 - A United States citizenship and immigration services employment authorization document or refugee travel document.
 - A United States certificate of naturalization.
 - A United States certificate of citizenship.
 - A tribal certificate of Indian blood.
 - A tribal or bureau of Indian affairs affidavit of birth.
 - Any other license that is issued by the federal government, any other state government, an agency of this state or a political subdivision of this state that requires proof of citizenship or lawful alien status before issuing the license.

NOTE: If your birth date does not appear on the document you provide to prove your legal residency, you will be required to submit an additional document to prove you meet the age requirement.

3. If the document you submit to prove your legal residency does not contain a photograph, you must also provide a government issued document that contains your photograph. Please provide one (1) of the following:
 - Driver license
 - State ID
 - Passport or Passport Card
4. Proof of PTCB Certification. Please provide one (1) of the following:
 - PTCB Certificate
 - PTCB Wall Card
 - Letter of Passing Score from PTCB
5. Arizona Fingerprint Clearance Card.
 - If you have a valid Arizona Fingerprint Clearance Card, submit a photocopy.
 - To obtain an Arizona Fingerprint Clearance Card contact the Arizona Department of Public Safety (DPS) or apply online using the fieldprint website. You may contact DPS by calling 602.223.2279 or faxing your request to 602.223.2947. DPS office hours are Monday through Friday, 8:00 am to 5:00 pm. To apply online, visit the fieldprint website, <http://fieldprintarizona.com/>. The statute for our agency is A.R.S. § 32-1904.

6. Documentation of any name changes. Acceptable documents include:

- Marriage License
- Divorce Decree (showing restoration of previous name)
- Court Order

7. If applicable, court records relating to any criminal charges or convictions, even if the charge or conviction was later dismissed, expunged or set aside.

PTCB certified technician application fees are pro-rated. The fees below may be paid by debit or credit card online. If you wish to pay by check or money order, you may apply by mail or in person. Application fees are NON-REFUNDABLE.
